Each 4-H member showing in this department is responsible for reading and complying with the **General Rules** for the Clark County Fair, the 4-H rules and regulations (the Clark County Fair General Rules and the 4-H General Rules documents are available on the Clark County Fair's website ([www.clarkcofair.com](http://www.clarkcofair.com)), and the special rules and regulations of this department.

#### **GENERAL INFORMATION:**

1. Items entered on display must stay in the 4-H Still Exhibit Area the entire time of the Clark County Fair. **RELEASE TIME WILL BE ON: SUNDAY, AUGUST 13 after 10 pm and MONDAY, AUGUST 14 between 9 am-noon.** If you are unable to be there at that time, please make arrangements to have your exhibits picked up. Some 4-H exhibits will be taken back to the 4-H Office-check first 360-397-6060 x5730.
2. **Entries will be accepted in the 4-H Still Exhibit area on Tuesday, August 1, from 10 am-8 pm.** Interview judging will be available to 4-H members at the time exhibits are entered if a judge is present in that department. Interview judging is a learning opportunity for 4-H members through feedback on his/her exhibit. Members may select one item per department for interview judging. For further information, (i.e. times and dates), about interview judging in various departments, contact the superintendent listed in the Exhibitor Guide.
3. **4-H members may only exhibit items in projects in which they are enrolled.**
4. Pre-registration forms for 4-H County Fair Activities will be available at the WSU/Clark County Extension 4-H Program office or online <http://extension.wsu.edu/clark/4hyouthfamilies/clarkcountyfair/> and due at the same location by the last business day of June. Members will participate in activities at assigned times, bringing all materials and supplies needed. Participants must arrive at the activity and be prepared to participate at the assigned time. Failure to start at the assigned time may result in forfeiture of time slot, being moved to another time allocation, and/or having the final ribbon lowered at least one placing. Judges will evaluate member at the time of the activity. Judges' decision is final.
5. Any worksheets needed by participants will be sent by email or mailed to the participants, after pre-registration. These worksheets must be completed and handed to the superintendent before the start of the activity. **They are to be completed in members' handwriting, or typed by youth.** Incomplete or missing worksheets may result in the lowering of ribbon color at least one placing for the activity. Any photos required for the activity will be attached to the worksheet when it is turned in.
6. **Building Security** - Any parent and/or leader, whose child is enrolled in projects displayed or activities in the 4-H Building, MUST sign up for a security shift. Sign up on Tuesday, August 1, 2017 "Entry Day" from 10 am-8 pm.

**4-H STATE FAIR** (September 1-24, 2017)

**4-H Still Exhibits/4-H Activities** are **required** to fill out and return all paperwork to Nancy Peck (Clark County 4-H Still Exhibits Superintendent for 4-H State Fair) no later than Monday, August 14 by Noon.

4-H State Fair paper work may also be picked up, filled out, and returned during Fair once judging is complete and exhibit qualifies. Nancy is located in the 4-H Kitchen area in Exhibit Hall A, Clark County Event Center on the Clark County Fairgrounds during Fair.

### **DIVISION 925: DISCOVERY**

**Points: Blue 8, Red 6, White 4**

#### **CLASS:**

1. Display panel of at least six minor forest products properly labeled (first-year members only).
2. Foliage specimens of ten native forest trees and shrubs properly mounted and labeled (first-year members only).
3. Foliage specimens of twenty native forest trees and shrubs properly mounted and labeled.
4. Seed samples of at least five native forest trees, in vials or plastic envelopes properly labeled.
5. Leaf prints of at least five (5) shrubs or trees.
6. Five kinds of native ferns mounted on panel and properly labeled.
7. Album of 10 different wild flowers (excluding trillium) pressed, mounted under pilofilm, and labeled with common name.
8. Worksheets on mapping or timber measurement exercise verified by club leader.
9. Fire posters or other signs designed and made by member as part of project work.
10. Display of six different wood samples approximately 2"x 4" in size and 5/16" thick sanded smooth, mounted, and properly labeled.
11. Biltmore stick, diameter tape, or other measuring device made by member.
12. Plant press or other useful article made of wood by club member.
13. Small log cross-section having annual rings labeled with historic dates or growth response to fertilizer or thinning.
14. A flat of forest tree seedlings grown by club member.
15. A decorative article made from forest materials of permanent type such as pods, cones, or catkins.
16. Folio of at least six photos approximately 3"x 5" size taken by the club member and devoted to one subject such as wild flowers, logging equipment, soil erosion, rodents, bird nests, insect damage or safety hazards.
17. Outdoor survival kit (assembled by exhibitor with carry-in case).
18. Diagram of section map showing location (X) of member's home, also describing this location in land survey terms.
19. Forest bud or fruit collection of at least five (5) native species.
20. Collection of at least six (6) native cones properly labeled.
21. Any other exhibit related to project work showing initiative, originality, and accomplishment.

**RULES & REGULATIONS:**

1. Exhibitor must be enrolled in one or more of the following the 4-H Projects: Riflery, Pistol, Shotgun, Black Powder/Muzzle Loading and Hunting. Project curriculum can be located on the WSU – 4-H web site: <http://pubs.wsu.edu/ListItems.aspx?Keyword=EM4426E>
2. General/Project leader of exhibitor must be enrolled and be certified 4H Shooting Sport instructor in the projects members are enrolled: Riflery, Pistol, Shotgun, Black Powder/Muzzle Loading, and Hunting.
3. Shooting Sports exhibits and shooting results/targets/ribbons will be in place for public viewing from August 4 thru August 13 in the East Wind of the E-Barns.
4. Exhibitors are required to do an hour or more of Shooting Sport Stewardship (see Division 110)
5. Members must pre-Register utilizing the Clark County Fair Still Exhibit form or available at WSU Clark County Extension (1919 NE 78 Street, Vancouver, WA). Entries must be turned in to the WSU Clark County Extension – 4-H Program office by the last business day of June.
6. Exhibitors must arrive at the activity (Shoot) and be prepared to participate at designated location, date, and time.
7. National Rifle Association small bore rules will govern this match, .22 caliber rifles only. Exhibitors must supply their own .22 rifles and shells. The Superintendent must approve rifles. The Shooting Sports superintendent must approve rifles.
8. The 4-H Shoot dates is Sunday, July 30, 2017 beginning at 8 am. Location of Shoot is the Wolverton Mountain Shooting Range. Contact Anita Gwinn 360-262-4701 for directions. Mandatory judges meeting at 9:00 a.m. followed by rifle shoot, there will be a trap shoot, cost \$5.00.

### **RULES AND REGULATIONS:**

1. Open to 4-H juniors, intermediates and seniors enrolled in the Sport Fishing Project.
2. Exhibits must be made during the current 4-H year. Exhibitor may enter six (6) exhibits, one item per lot.

**Points: Blue 10, Red 8, White 6.**

### **CLASS:**

1. Poster that may show any topic related to the fishing project.
2. Tackle box that will include essential tools and tackle.
3. Any accessory showing initiative, originality and accomplishment.
4. At least 4 knots mounted on a 9"x12" display panel with a brief description of when to use each knot.
5. A collection of at least 4 handmade flies or lures displayed on a panel no larger than 6"x9" Label flies by name and lures by type of fish sought after.
6. Notebook on safety, club projects, or club trips. Include pictures with explanations of where the picture was taken, date, and time of day, weather conditions, how many fish were caught, and how many fish were kept.
