GENERAL INFORMATION:

1. Items entered on display must stay in the 4-H designated area the entire time of the Clark County Fair. Members may pick up their exhibits after 10 pm on the last day of the Fair or the Monday following Fair from 9 am to Noon. If you are unable to be there at that time, please make arrangements to have your exhibits picked up. Some 4-H exhibits will be taken back to the 4-H Office-check first 564-397-5730.

2. **Entries will be accepted in the 4-H Still Exhibit Area in Exhibition Hall C on Tuesday August 4th, from 10 am to 7 pm.** Interview judging will be available to 4-H members at the time exhibits are entered if a judge is present in that department. Interview judging is a learning opportunity for 4-H members through feedback on his/her exhibit. Members may select one item per department for interview judging. For further information, (i.e. times and dates), about interview judging in various departments, contact the superintendent listed in the Exhibitor Guide.

3. **4-H members may only exhibit items in projects in which they are enrolled. Superintendents will consult with the 4-H Office in the case that 4-H projects and 4-H online project categories are not clearly connected.**

4. Pre-registration forms for 4-H County Fair Activities will be available at the WSU/Clark County Extension 4-H Program office or online

<http://extension.wsu.edu/clark/4hyouthfamilies/clarkcountyfair/> and due at the same location by the last business day of June. (Or online at FairEntry.com; call 564-397-5730 with questions). Members will participate in activities at assigned times, bringing all materials and supplies needed. Participants must arrive at the activity and be prepared to participate at the assigned time. Failure to start at the assigned time may result in forfeiture of time slot, being moved to another time allocation, and/or having the final ribbon lowered at least one placing. Judges will evaluate member at the time of the activity. Judges' decision is final.

5. Prior to Clark County Fair, 4-H participants will be emailed date and time of chosen activity and directed to the site for 4-H worksheets (<http://extension.wsu.edu/clark/4hyouthfamilies/clarkcountyfair/>) required by some 4-H Activities, once pre-registration is completed. These worksheets must be completed and handed to the superintendent before the start of the activity. **They are to be completed in members' handwriting, or typed by youth.** Incomplete or missing worksheets may result in the lowering of ribbon color at least one placing for the activity. Any photos required for the activity will be attached to the worksheet when it is turned in.

6. **Building Security - Any parent and/or leader, whose child is enrolled in projects displayed or activities in the 4-H Building MUST sign up for a security shift. Sign up Tuesday, August 4th (Entry Day) from 10 am- 7 pm in the 4-H Still Exhibit Area Exhibit Hall C in the Event Center on the Clark County Fair Grounds.**

7. 4-H State Fair

4-H Still Exhibits/4-H Activities are required to sign up online and all projects to State Fair Coordinators no later than Monday, August 17 by noon. Coordinators will be present from 9 am - Noon on Monday.

4-H State Fair paperwork may be done online once judging is complete and exhibit qualifies.

Deadline for 4-H Still Exhibit entries exhibiting at 4-H State Fair: Monday, August 17 by Noon! Entries are received in the Clark County Event Center, Exhibit Hall C, State Fair Coordinator. No entries will be accepted after Noon.

- **All participants in the Consumer Project and all Fashion Revue participants must take part in a Style Show in order to obtain their premiums. The Style Show is scheduled for Friday, August 7, at 6:15 pm, Clark County Fair – Kids Park Stage. Participants should meet at 5:45 pm in the 4-H area in Exhibition Hall C at the Clark County Event Center at the**

Fairgrounds.

1. All 4-H members enrolled in the current 4-H year may take part in this project. Member does not need to be enrolled in a clothing project.
2. The purpose of this project is to help the individual coordinate an attractive outfit for the best buy and/or justify the reasons for selecting outfit entered.
3. A participant is to model a garment he or she has selected and purchased. Clothing may be purchased new or used. Gifts of clothing, either new or used, may be used for only a portion of the major clothing items of the outfit. Items may be used only one year. Accessories i.e., purses, scarves, jewelry, footwear may be sewn by the participant. One garment may be sewn on the Senior Level **if** it fits with the other three pieces.
4. Evaluation will be on: the individual, the outfit on the individual, the outfit for the intended purpose, and the justification of money spent.
5. A member can participate in both the Clothing Selection event and Fashion Revue
6. A worksheet showing the cost of the outfit has to be prepared. This worksheet will be sent to the participant when he or she pre-registers for this activity. A photograph of participant wearing the outfit and carrying extras must accompany the completed worksheet that is presented to the judge. Participant must complete the worksheet before arriving for the activity.
7. Cloverbuds may participate in Consumer Selection and Fashion Revue. They will fill out no paperwork and will not be judged during their participation on Tuesday, August 4th. Cloverbuds members will receive help on Tuesday, August 4th, writing their short Style Revue commentary and help modeling their outfits. They should bring a photo of themselves wearing their outfit for display at the Clark County Fair. All primaries will receive participation ribbons.
8. Exhibit must remain in the 4-H Area for display during the Clark County Fair to receive premium points.
9. Seniors may select as many as four pieces (no more) - or a three-way outfit for wardrobe concept. Seniors should be prepared to model all garments for the judges.
10. **Consumer garments will be taken with participants after judging.** Return garments to the 4-H Area when you take part in Style Show and plan to leave them for the duration of the Clark County Fair. Clothing Projects can be picked up from 10 -11 pm on August 10 or Monday, August 11 from 9 am to Noon.

2. Participants must fill out form **EMO682E - Personal Data Sheet-State Fashion Revue Information (7/01)** and bring the completed form to the activity. Forms can be picked up at the WSU/Clark County Extension Office or on line at <https://pubs.wsu.edu/ListCategories.aspx?TopicID=7>
3. Participants must fill out the form Fashion Revue Commentary and bring the completed form

to the activity. Forms can be downloaded online at <https://pubs.wsu.edu/ListItems.aspx?Keyword=Fashion%20Revue%20Commentary>

The worksheets must be completed by the 4-Her.

4. All garments must have care labels. In addition, each participant should bring to judging a 3x5 card with the care instructions written on them for each garment being entered.
5. A photograph of the garment on the contestant (in addition to the photograph attached to the personal data sheet) must be presented with contestant's entry forms for Fashion Revue, prior to judging. This photograph is used for display with garment.
6. Judging for Construction will take place on Tuesday, August 4th following the completion of Fashion Revue judging at 3 pm. Plan to leave your garments at the fairgrounds after Fashion Revue judging. Garments must remain in the 4-H Area for display during the Clark County Fair and cannot be used in other contests during the Clark County Fair.
7. **Cloverbud member participants:** Cloverbud members may participate in Fashion Revue. They will fill out no paperwork and will not be judged during their participation on Tuesday, August 4th. Cloverbuds will receive help writing their short style revue commentary and modeling their outfits. They should bring a photo of themselves wearing their outfit for display at the Clark County Fair. The Cloverbud participants will take part in the Style Show for Fashion Revue on Friday, August 1 and will receive participation ribbons.
8. A contestant must be enrolled in a corresponding Clothing & Textiles, Knitting, or Crochet projects that fits the garment. (Superintendent will consult with the 4-H Office in the case that the 4-H projects and 4H online project categories are not clearly connected.) The garment modeled may be knitted or crocheted by contestant. Entry to be judged must be garment, not accessory.
9. A member can enter only one division of the Fashion Revue contest. Garments made by 4-H members for young children may be modeled by those children, with 4-H member guiding them through the modeling. **Garments made for young children will not qualify to go to State Fair.**
10. Accessories may be made by contestant or purchased. These could include hats, belts, purses, scarves, and embellishments. Accessories are not judged for construction as part of the garment, only as they add to the overall look and appropriateness to the outfit. Contestant should NOT take these into consideration when selecting category or number of details in outfit.
11. Items can only be entered once and must have been completed since the previous year's fair. Worn or used items will be disqualified.
12. All contestants must:
 - A. Model their garments at the Style Show.
 - B. Exhibit their garments at the Clark County Fair.
13. The Fashion Revue Contest will be judged on the basis of:
 - A. General appearance (40%)
 - B. Construction as it affects appearance (40%)
 - C. Knowledge of subject matter (20%)

- Interview judging will be held from 12 - 8 pm on day of exhibit entry.
- Exhibitors may enter 10 class numbers, possibly more with permission of superintendent.
- More than one entry per Class is acceptable, but each must be different.
- If an entry has more than one article, each article should be listed on entry form and have an attached card.
- Each entry must have sewing as the primary construction, unless otherwise

noted in the book.

- All children’s sleepwear, infant through size 12 must be made of flame-retardant fabric.

6. Read all information in your food activity section, as each one may have different information. Be familiar with specific rules for Foods Activities found in current project material. Also check EM4733E– 4-H Food Activity Guidelines (<https://pubs.wsu.edu/ListItems.aspx?Keyword=EM4733E>). Set the table for all kitchen activities except Lunch on the Go and Food Preservation Activity. Include tablecloth or place mats and appropriate settings. May also use a centerpiece.

7. You may not pre-prepare or pre-measure **any** ingredients to be used in your product.

8. No alcoholic beverage may be used as an ingredient in any 4-H food product or served at a meal.

9. A 4-H member may prepare the same product in only one kitchen activity. If that product or one very similar is prepared in more than one activity, the activity with the most premium points will be disqualified for ribbon, premiums, and advancement to state. This does not include Table Setting, which can use the same menu as a kitchen activity.

12. Superintendent will give a list of those eligible for participation at the state fair to the

State 4-H Fair Coordinator.

13. Disregarding regulations may result in lowering a ribbon color or disqualification. Problems or irregularities being brought to the attention of the judge or superintendent after the awarding of a ribbon in an activity may cause reconsideration of that ribbon and eligibility for State Fair.

2. All products are to be exhibited in clean, standard canning jars. Other containers will be disqualified. Pint jars minimum size for fruit, vegetables, meats, and pickles. 1/2 pint jars minimum size for jellies, jams, and various preserves.
3. Please bring Fair entry in with new screw bands on jars. Remember to thoroughly clean outside of jars. Jars may be opened at the judge's option.
4. All canning exhibits must be labeled, using labels (C0803 4-H Canned Food or C0804 4-H Dried Foods) available at the WSU/Clark County Extension Office or at: <https://pubs.wsu.edu/ListItems.aspx?Keyword=food%20labels>

The label (Canned or Dried):

- centered on the lid of the jar or front of the packaging for dried foods
- kind of food
- type of pack (raw or hot)

- processing method used
- time processed
- date processed
- class and lot number
- name of exhibitor

5. Indicate on labels for canned tomatoes if citric acid or lemon juice has been added, e.g., "1/2 tsp. citric acid added."

6. Processing methods and times must follow current Washington State University and USDA recommendations. USDA recipes are not required for jams, and jellies, but USDA processing recommendations must be followed. Use boiling water bath for jams and jellies.
