## *Waiver of Liability Form*

In consideration of any application being accepted for participation in the Clark County Fair Court tryout process, I hereby agree to abide by the rules and regulations of the Clark County Fair Court Committee and the Clark County Fair Court tryouts and understand that any violation of the rules and regulations may disqualify me from participation.

I further agree to indemnify and hold harmless committee members, agents, and employees or any of the contestants in the Clark County Fair Court tryouts, together with those persons and entities who donate horses, floats, trailers, and vehicles for use by myself and other contestants from any claims resulting from the loss, accident, or injury received by me in connection with participation by me in any event, performance, parade, or other activity.

I also agree to indemnify and hold harmless committee members, agents, and employees of the Clark County Fair Association for the entire term of my reign, if I am chosen as a titleholder for all of the previously noted reasons of loss, accident, or injury, as well as any decisions made regarding the title of Clark County Fair Court Queen or Clark County Fair Court Princess.,

This Waiver Agreement will remain in force not only for tryouts, but also from the time the titleholder is announced through the holdover period as Clark County Fair Court Elect, and then through the term as the Clark County Fair Court Queen or Clark County Fair Court Princess. Also, I hereby release the right, title, and claim of any photographs that may be taken by the Clark County Fair Association for use in promotion and publicity.
